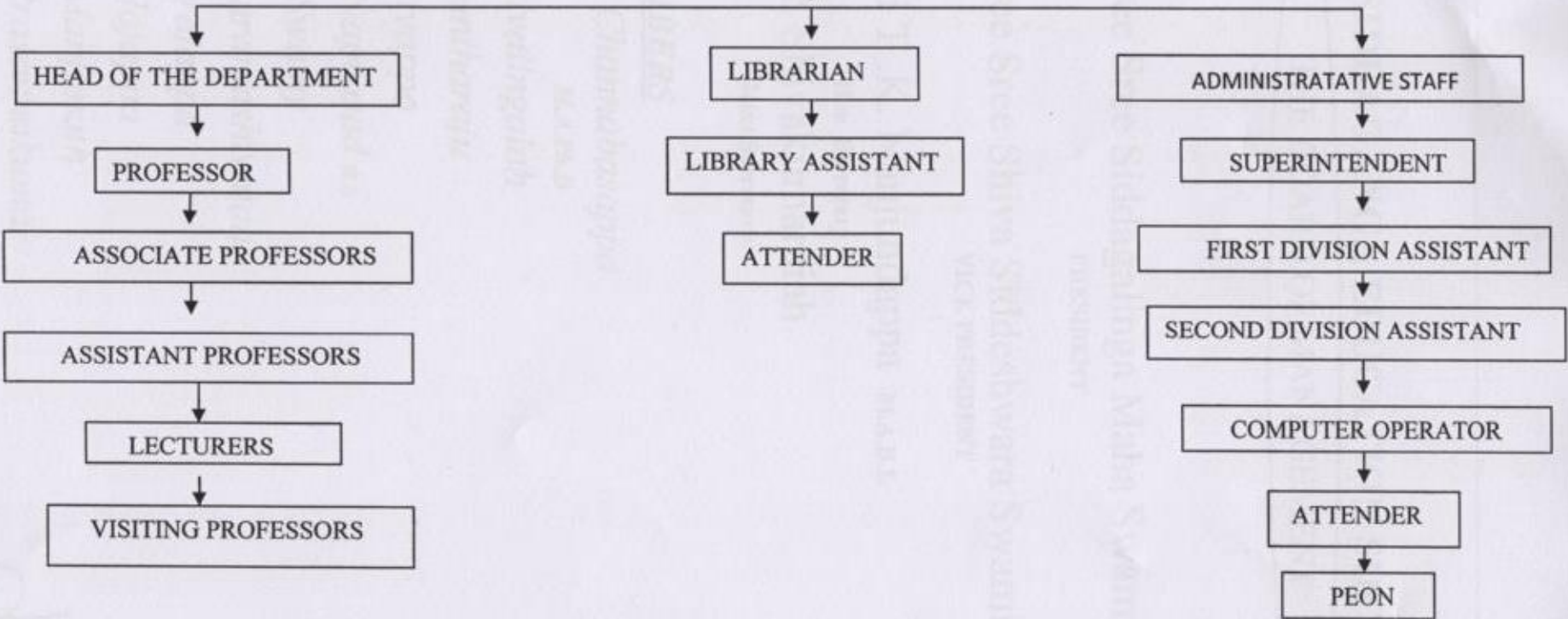



## Memorandum of Association and Bye-Laws of Sree Siddaganga Education Society

Sree Siddaganga Math- 572 104.  
Tumkur District.

Registered under the Karnataka Societies Act No. 17 of 1960 dated  
17th July 1963.

**1. Name of the Society :**

Sree Siddaganga Education Society

**2. Objects of the Society :**

- a) To promote education and culture by establishing, maintaining or managing Colleges, Schools, Institutions, Training Centres, Medical Colleges, Technical Colleges, Hospitals, Research Centres and Libraries within the Union of India which shall be open to students of all communities.
- b) To establish Hostels and Boarding homes for the comfort of students and teachers.
- c) To print and publish books of Literary, Cultural, Religious and Scientific value and to establish printing press for this object.
- d) To arrange for lectures, seminars, symposia and conferences for promoting Education, Culture.
- e) To acquire, invest, dispose of, transfer or otherwise deal with the property of the Society in such a manner so as to enable the society to carry out and promote its objects effectively.
- f) To become member of any organisation of similar nature and to participate or to collaborate with any scientific and cultural



organisation to promote advanced Research and Technology and other educational activities.

- g) To carry out the above said objects of the society by itself or by creating and promoting independent Trust or funds and to take all incidental step to carryout the objects effectively.
- h) To provide houses and other amenities to teachers and staffs engaged in the objects (a) to (g).
- i) To do all other acts which are necessary and incidental for promoting the objects of the society as per the guidelines and norms and statutes which may be issued by the Government of Karnataka and Central Government from time to time.
- j) To acquire any movable or immovable properties, by way of purchase, lease or rent from any person or persons whatsoever for deriving revenue or for augmenting the resources of the society for the above objects and to borrow funds, with or without security for the effective running of the institutions run by the society.

The objects of the society shall be carried on by the management without any discrimination of the beneficiaries on the basis of caste, creed, community or religion and the objects shall be in accordance with the provision of section 2(15) of Income Tax Act, 1961.

Any surplus funds or income of the society shall not be distributed among the members or of office bearers of the society but shall be used only for the purpose of promoting the objects of the society.

To acquire, take over and manage or run any educational institutions that are run by any other educational institutions or trust as the case may be.

## **RULES AND REGULATIONS OF THE SREE SIDDAGANGA EDUCATION SOCIETY(R.)**

- I) The name of the society shall be "Sree Siddaganga Education Society, Sree Siddaganga' with its head Quarters at Sree Siddaganga Math, Tumkur district.
- II) **DEFINITIONS** : In this Memorandum, unless there is anything repugnant to the subject matter of context.
  - a) "SOCIETY" means Sree Siddaganga Education Society, Sree Siddaganga Math.
  - b) "ACT" means Karnataka Societies Registration Act, 1960.
  - c) "REGISTRAR" means the Registrar of the societies in Karnataka, Bangalore.
  - d) "PRESIDENT" means the President of the Society.
  - e) "BOARD" means the Board of Management formed under the Rules contained in these Regulations.
  - f) "INSTITUTIONS" means, the colleges or Institutes or any other Institutions started or that may be started by the said Sree Siddaganga Education Society.

### **III. REGISTERED ADDRESS**

Registered Address of the Society shall be "Sree Siddaganga Education society, Sree Siddaganga Math, Tumkur Taluk & District, Karnataka

If there is any change of address it shall be intimated to the Registrar within a month from the date on which the change was made.



#### **IV) MEMBERSHIP :**

- a) The society shall consists of patrons and life members.
- b) Any person who is aged above 18 years and who is of sound mind and who has not been convicted of any offence involving moral turpitude and who agrees with the objects of the society.

#### **MAY BECOME :**

- I) A patron by paying not less than Rs. 3,000/- (Three thousand) to the funds of the society as contribution.
- II) A life member by paying not less than Rs. 1,000/- (One thousand) to the funds of the Society as contribution.

#### **V) MANAGEMENT :**

For the Management of the affairs connected with the Society there shall be the following Bodies.

##### **(A) PRESIDENT :**

Sree Sree Swamiji of Sree Siddaganga Math shall be the President of the Society for all time.

His holiness Dr. Sree Shivakumara Swamigalu of Sree Siddaganga Math, the founder President of the Society, shall be the President of the Society for his life time or until such time has he chooses to retire.

His subsequent succssors to Sree Siddaganga Math shall be the successor as President of the Society.

##### **(B) BOARD OF MANAGEMENT :**

- I) The Board of Management shall be constituted at the end of every third year during the Annual General Body Meeting of the Society and the members being eligible for re-election.

II) If any vacancy arises owing to death or resignation of any elected member of the Board of Management, It shall be filled up by the Board, by nominating any person who a member of the society by way of majority decision. If no such person is appointed by the Board to the vacancy, the President shall have the power to fill up the vacancy by way of nomination.

III) All members (Patrons and life members) are eligible to take part in the General Body Meeting and participate in the voting. Every voter is eligible to contest the Election to the Board of Management.

IV) The Society shall have a Vice-President, a secretary and a joint Secretary nominated by the President.

V) The term of the office of the Vice-President, The Secretary and Joint Secretary shall be co-terminous with that of the Board of Management.

#### **VI) CONSTITUTION OF THE BOARD OF MANAGEMENT :**

**The Constitution of the Board shall be as follows :**

- a) The strength of the Board shall be 15 (fifteen)
- b) The Board shall consists of
  - i) The President of the Society shall also be the President of the Board.
  - ii) Vice-President
  - iii) Secretary
  - iv) Joint Secretary
  - v) Seven members to be selected from the General Body
  - vi) Four members to be nominated by the President.



## **VII) FUNCTIONS OF THE BOARD OF MANAGEMENT :**

It shall be the business of the Board :

- i) To manage the affairs of the institutions run by the society and to regulate the income and expenditure.
- ii) To determine the cadre and grades of the departments and to create, suspend or abolish posts to fix emoluments and terms and conditions of the service of the employees of the Institutions and to take disciplinary proceedings as per rules frame from time to time.
- iii) To appoint staff in accordance with the regulations drawn up by the Board for the purpose from time to time.
- iv) To grant allowances, advances, leave and to determine the conditions of the service, contracts and to grant extension of service to the members of the staff.
- v) To impose penalties on the members of the staff in accordance with the procedure to be laid down for the purpose. This power may be delegated to the Head of the institution, if necessary.
- vi) To consider the annual report and Audited accounts for the previous financial year and to make estimate for the ensuing year in respect of the institutions run by the society and to take decisions thereon.
- vii) To fix and regulate and fee in the institutions run by the society subject to the ratification of the General Body.
- viii) To place before the General Body Annual Reports regarding the progress made along with the statement of the Income and Expenditure.

- ix) And to take all other things (in accordance with the Rules) as are necessary for the proper management of the Institutions subject to the general control of the General body.
- x) The president of the Board shall preside over the meetings of the Board.

In the absence of the President, the Vice-President shall preside over the meetings of the Board and in the absence of both the President and the Vice-President, the members present shall elect a President from the among them to conduct the day's meeting.

- xi) The Board of management shall meet atleast once in three months and whenever found necessary as directed by the President.
- xii) The quorum for a board meeting shall be 5(five) (including the President) There shall be no quorum restriction regarding the transaction of the business in an adjourned meeting, if the previous meeting had been adjourned for want of quorum. No new subjects shall be considered in such adjourned meeting.
- xiii) The President of the day shall have a casting vote in case of an equality of votes.

## **VIII) GENERAL BODY MEETING OF THE SOCIETY :**

- a) There shall be atleast one General Body Meeting of the Society every year convened within three months of official year of the society and as per section 11 of Karnataka Societies Regn. Act 1960.

All questions to be brought before the General Body Meeting of the society or the Board shall be decided by a majority of votes, the President having casting vote in case of an equality of votes.



- b) The President (or the Vice-President) in the absence of the President) shall preside over the General Body meeting of the Society. In case both the President and Vice-President are absent the members present shall elect a President from among them to conduct the day's meeting.
- c) Amendments, alterations, substitutions or the deletions in the memorandum of association and the rules shall be decided by the General Body. But however such amendments shall not be repugnant to the provisions of section 2(15), 10, 11, 12, 13 and 80G of Income Tax Act, 1961 and further, such amendments shall be carried out with the prior knowledge and approval of Commissioner of Income Tax, Karnataka, Bangalore.
- d) Quorum for the General Body shall be 25 or one third of the members which ever is lower. There shall be no quorum restriction regarding the transactions of business in an adjourned meeting if the previous meeting had been adjourned for want of quorum.
- e) Annual returns shall be filed with Registrar as required under section 13 of the Act.

**IX) SECRETARY :**

It shall be the duty of the Secretary (or Joint Secretary in the absence of the Secretary) to convene meetings, to issue circulars, to correspond under the directions of the President, to take all action in the compliance with the decision of the Board of management and as per the directions of the President.

**X) FINANCE**

- i) The property and the funds of the society shall belong to the society collectively and no member shall have any proprietary rights over them.

- ii) i) The accounting year of the society shall be the financial year commencing from 1st April to 31st March of every year.
- ii) Accounts of the society shall be audited by a chartered accountant duly appointed by the Board / general Body as the case may be every year.
- iii) The bank accounts shall be opened in the name of the society/institutions as the case may be and shall be operated by the President singly or by the Vice-President and Secretary jointly.
- iv) Investments :** The surplus funds of the society / institutions shall be invested in scheduled banks or Government securities and other approved financial institutions subject to the provisions of section 11(5) read with section 13 of the Income Tax Act, 1961.

**XI) WINDING UP / DISSOLUTION**

In the event of winding up or dissolution of the society the assets and liabilities of the Society shall not be distributed among the members but shall be transferred to another society / trust / institution having similar objects as of the society which are registered U/S 12A recognized U/S 80G of the IT Act, 1961 with the prior knowledge and approval by the CIT, Karnataka, Bangalore.

## Objectives:

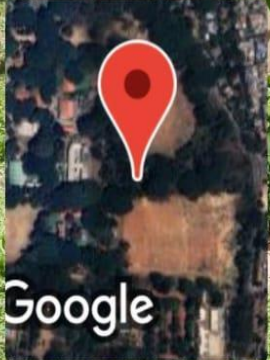
